

**RESOLUTION #644**  
**Amending Resolution #633**

**Banner Permits**  
**Borough of Kulpmont**

**WHEREAS**, The Borough of Kulpmont obtains banner permits for the erection of banners across state highways located within the Borough; and

**WHEREAS**, The Borough of Kulpmont desires to pass this resolution, which includes all banners, erected in the Borough of Kulpmont on a yearly basis; and

**NOW, THEREFORE, BE IT RESOLVED**, That the Borough of Kulpmont, County of Northumberland, does herewith provide the following information as required by the Pennsylvania Department of Transportation for all of the following banner permits to be erected annually as stated, with the Borough of Kulpmont:

1. The locations will be as follows:  
Rt. 61 – Chestnut Street – 5<sup>th</sup> & Chestnut Streets & Chestnut & 14<sup>th</sup> Streets  
Rt. 61 – Chestnut Street – 8<sup>th</sup> & Chestnut Streets
2. Vertical ground clearance will be at a minimum of 17'6"
3. The size of the plastic banners will be 2' wide by 10' long.
4. Event, Description of Message, Installation and Removal Dates:
  - A. Annual Kulpmont Car Cruise June 10, 2007 – 1<sup>st</sup> week in June until 2<sup>nd</sup> week in June.
  - B. Kulpmont Borough Fire Department – Fire Prevention Week beginning October 7, until October 13, 2007 – week of October 1, 2007 until week of October 15, 2007.
  - C. **Geisinger Life Program – Grand Opening January 2, 2008 – week of December 17, 2007 until week of January 7, 2008**
5. Commercial advertising will be no more than twenty percent (20%) of the message.
6. Temporary cables will be used in the erection of the banners.
7. Traffic control for erecting and removing the banner will be in accordance with the most current PENNDOT publication for Work Zone Traffic Control.
8. The Borough of Kulpmont assumes the responsibility for erecting, maintaining, and removing the banners.
9. The Borough agrees to indemnify and hold harmless the Pennsylvania Department of Transportation and Department employees from liability for damages or injury to any persons or property associated with the placement of banners.
10. The Borough authorizes the following herewith identified, Joseph A. Winhofer - Council President and Robert M. Slaby, Jr. - Borough Secretary, to execute any and all documents as may be required by the Pennsylvania Department of Transportation.
