ORDINANCE NO.2015-04

ORDINANCE OF THE BOROUGH OF KULPMONT, NORTHUMBERLAND COUNTY,
PENNSYLVANIA, DECLARING CONTRACTOR REGISTRATION FEES.

SECTION I: SHORT TITLE

This ordinance shall be known as the Kulpmont Contractor Registration and Contractor Registration Fees Ordinance.

SECTION II: INTENT

To apply for, and receive construction permits you MUST have a contractor's registration card issued by the Pennsylvania Attorney General's Office.

SECTION III: REGISTRATION

All contractors are required to have current registration with the Borough of Kulpmont, prior to the issuance of any building, electrical, plumbing, mechanical or other type of permit(s). The general contractor of the job site shall be responsible for ensuring that the license is displayed at the approved location. At a minimum, a black and white copy of the license must be produced immediately upon request by any Borough of Kulpmont official or resident. A list of Registered Contractors is available at Borough Hall. This list is updated on a quarterly basis for public Access.

SECTION IV: LICENSE APPLICATION AND FEES

Licenses are issued for the current year beginning January 1st and are valid for one year. The Borough mails out reminder letters at the beginning of December prior to the expiration date.

Licenses that are not renewed within thirty (30) days of January are void and may only be renewed in accordance with city and state law.

1. Contractor's License Application (available on Borough Website at www.boroughofkulpmont.org);
2. Provide a Certificate of Liability Insurance indicating a minimum General Liability coverage of \$500,000.00;
3. Backflow testers must provide current State of Pennsylvania license and current test gauge kit certifications;
4. Registration fee: Yearly fee of \$100.00

SECTION V: ADDITIONAL AUTHORITY TO GRANT PERMITS

The Council reserves unto itself, pursuant to the provisions contained in this Ordinance, the right to permit otherwise prohibited activities within the Borough of Kulpmont, subject to the payment of a permit fee in an amount established by Council, and subject further to the compliance with such additional rules and regulations as may be established by the Council incident to the granting of said permit.

SECTION VI: PENALTY FOR VIOLATION

The fine for violation of any provision of this section shall be up to two thousand dollars (\$2,000.00) per violation, with each day that the violation continues, being a separate violation. The enforcement of this section shall be imposed by the building official or his designated representatives, the fire chief, or any certified code enforcement officer or police officer, in accordance with the enforcement provisions.

SECTION VII: EFFECTIVE DATE

This ordinance shall become effective 30 days after it is adopted by the Borough of Kulpmont. The registration and annual fee requirements set forth herein apply for calendar year 2016 and all subsequent years until expressly repealed or modified by the Borough.
