AMENDING ORDINANCE 2014-02

**BOROUGH OF KULPMONT
NORTHUMBERLAND COUNTY, PENNSYLVANIA**

AN ORDINANCE OF THE BOROUGH OF KULPMONT, NORTHUMBERLAND COUNTY, PENNSYLVANIA, AMENDING AND REPEALING SECTIONS OF INCONSISTENT ORDINANCES; AND PROVIDING FOR PROHIBITED PARKING OF CERTAIN VEHICLES ON BOROUGH STREETS FOR A LENGTH OF TIME OTHER THAN SHORT TERM PARKING, IMPOSING OTHER FINES FOR SAID PARKING VIOLATIONS WITHIN THE BOROUGH OF KULPMONT, OF NOTICE OF SAME, IMPOSING PENALTIES AND REPEALING INCONSISTENT ORDINANCES.

BE IT ORDAINED by the Council of the Borough of Kulpmont, Northumberland County, Pennsylvania, and it is hereby **ORDAINED AND ENACTED** by and with the authority of the same as follows.

SECTION I SHORT TITLE

This Ordinance No. 2015-05 shall be known and may be cited as the “Oversize Vehicle Ordinance.” Amending Ordinance 2014-02.

SECTION II ACTIVITIES WHEREIN THE OVERSIZE VEHICLE ORDINANCE IS EFFECTIVE

This Ordinance shall affect issuance of parking fines in the following circumstances:

1. Hazardous and unsafe traffic conditions will be created on certain streets and intersections of streets unless the following parking restrictions are enacted, restrictions must be imposed in the interest of noise abatement and to provide residents with peaceful and quiet enjoyment in their homes and neighborhoods.
2. It shall be unlawful for an operator or owner to park, stop or stand a commercial motor vehicle **exceeding SEVEN and ONE-HALF (7 ½ FEET in width or greater,** or a tractor trailer cab or a motor home, or a recreational vehicle, or a camping trailer, boat, or any other similar motorized vehicle or device that cannot be moved under its own power, on any borough street for other than short term which is three continuous hours or less.
3. **Borough Streets affected in which commercial motor vehicles exceeding seven and one-half (7-1/2) feet in width or greater are those running East**

and West in the Borough of Kulpmont and include: Ash Street, Pine Street, Walnut Street, Spruce Street, Maple Street, Oak Street, Scott Street, Fir Street, Poplar Street and Wood Street. **Borough Streets affected running North and South in which commercial Motor vehicles exceeding seven and one-half (7-1/2) feet in width or greater are those running North and South in the Borough of Kulpmont and include:** Fifth (5th) Street, Sixth (6th) Street, Eleventh (11th) Street, Twelfth (12th) Street, Thirteenth (13th) Street, Fourteenth (14th) Street, Fifteenth (15th) Street and Sixteenth (16th) Street.

4. DEFINITIONS. The TERM “short term” as used in this Ordinance refers to three continuous hours or less.

SECTION III PENALTIES

The Borough of Kulpmont may impose a fee against all persons violating Section II of this Ordinance that will amount to Three -Hundred (\$300.00) Dollars plus costs and a term of imprisonment of not more than five (5) days.

SECTION IV SEVERABILITY

If ANY provision of this Ordinance 2014-02, or ANY subsection thereof is found to be illegal or invalid, such illegality or invalidity shall not affect or impair ANY of the remaining provisions of this Ordinance, or any subsections thereunder. It is hereby declared as the intent of the Borough that this Ordinance 2014-02, would not have been enacted if ANY per se illegal or invalid provisions were included herein. If ANY provision would be found to exist, such invalid provisions would be stricken.

SECTION V EFFECTIVE DATE

This Ordinance No. 2014-02, is here declared to be urgent for the preservation for the peace, health, safety and comfort of the residents of the Borough of Kulpmont, and shall take effect and be in full force immediately after its passage.

SECTION VI REPEALER

All ordinances or parts of Ordinances in conflict or inconsistent herewith shall be and the same.
